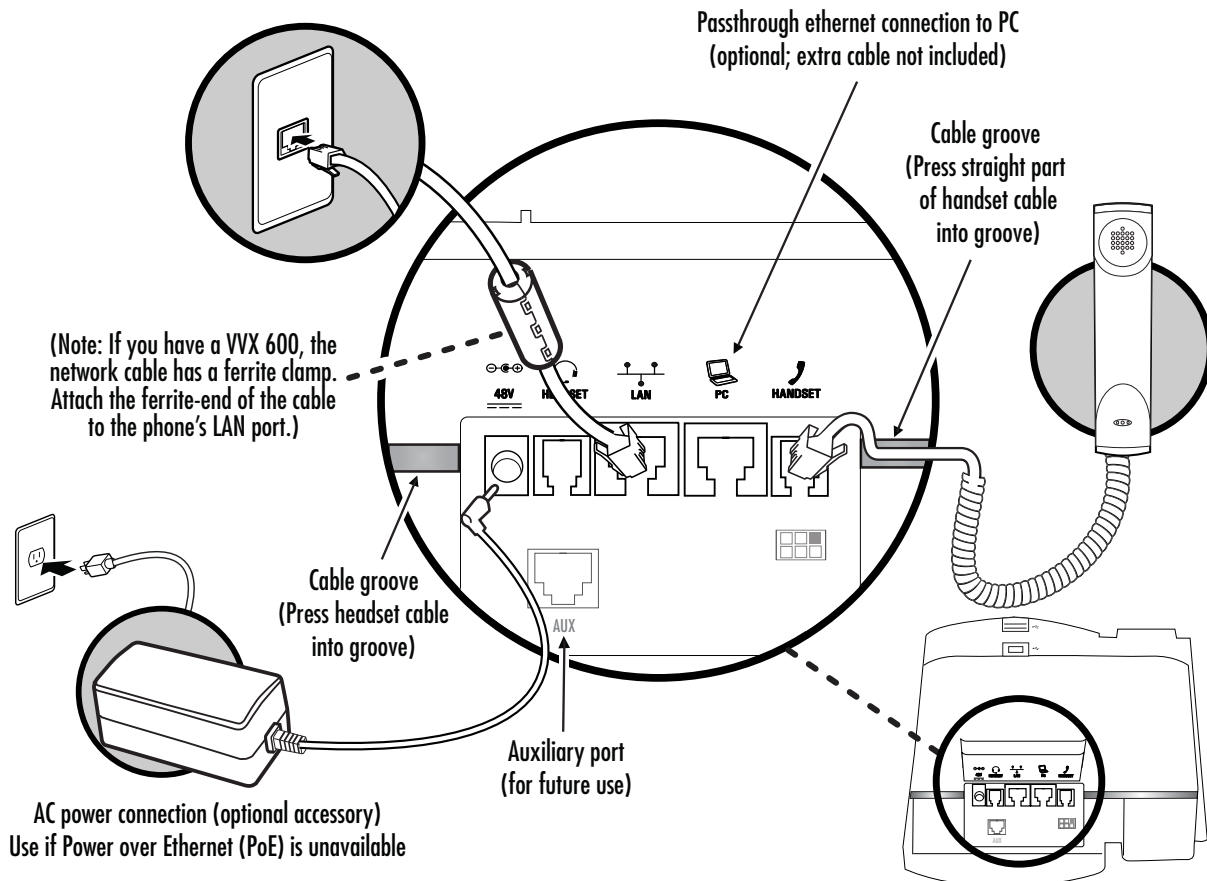


AC Power Cord and Adapter

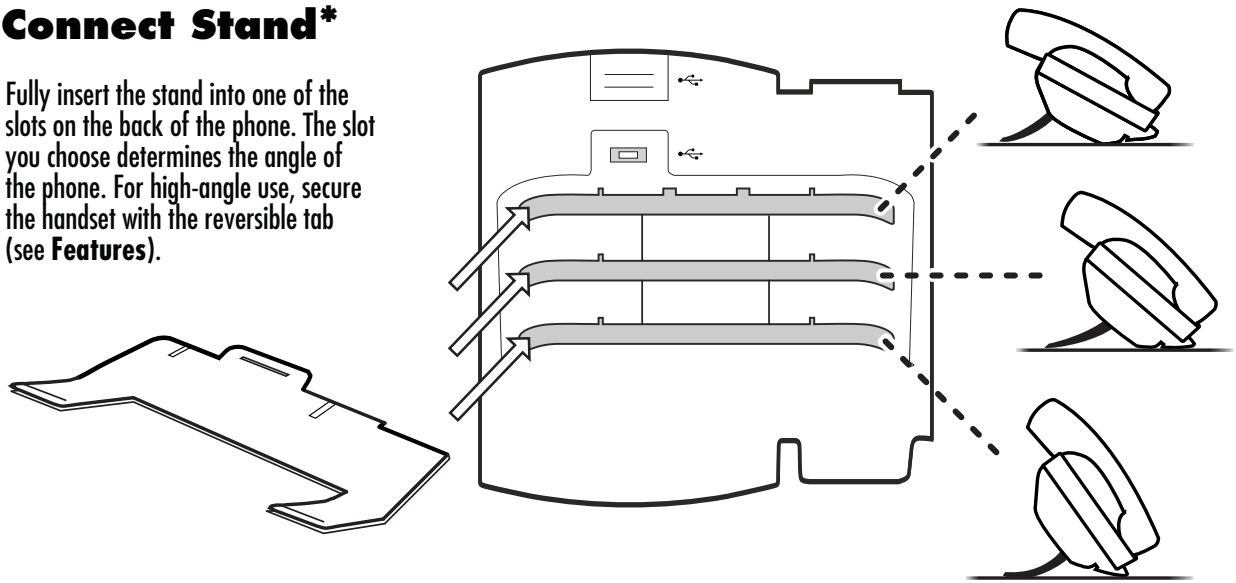


# Connect Cables



## Connect Stand\*

Fully insert the stand into one of the slots on the back of the phone. The slot you choose determines the angle of the phone. For high-angle use, secure the handset with the reversible tab (see **Features**).



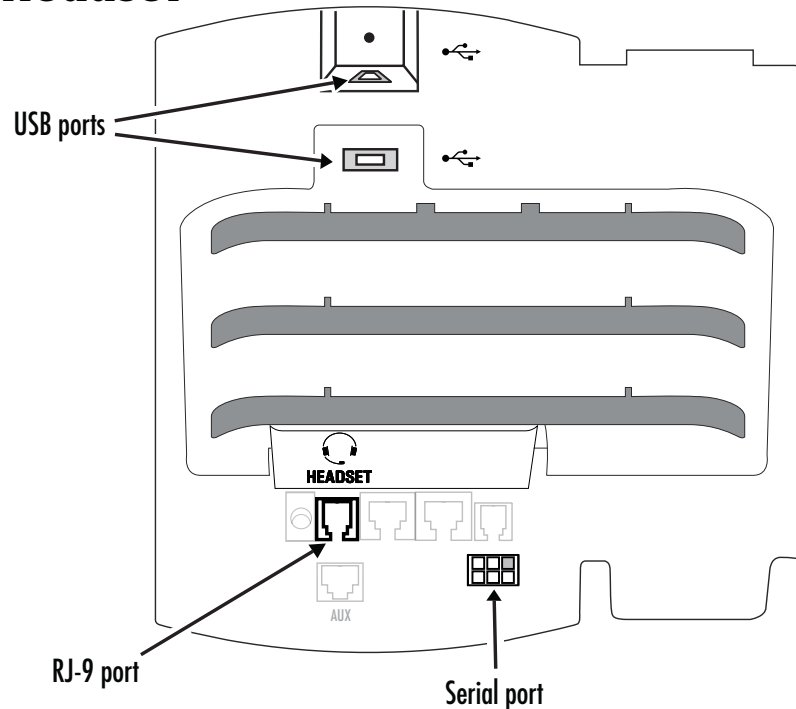

Note: Your phone supports wired and wireless headsets, including electronic hookswitch (EHS) headsets. VVX 600 phones also support Bluetooth headsets.

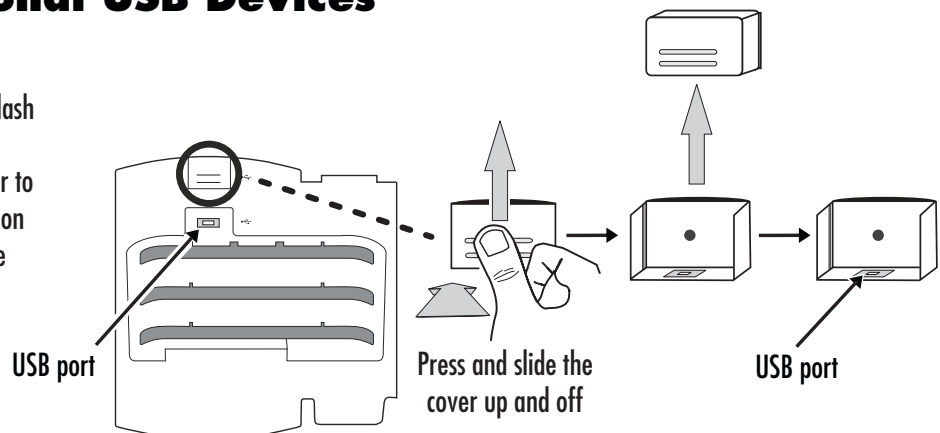
